Free Space Stones: 1' x 2 ' flat stones only on a cement slab that is 4 to 5 inches thick and is 1 foot wide and 2 foot long.

## Oak Lawn Cemetery Rules and Regulations

- 1. Spaces and lots shall not be used for any purpose other than human burial.
- 2. All spaces and lots sold are subject to Perpetual Care. All work, care and maintenance shall be done by employees of the cemetery under supervision and direction of the Superintendent.
- 3. No interment or disinterment shall be made by anyone other than cemetery employees under the direction and supervision of a licensed funeral director and embalmer who must have a disinterment permit from the Oklahoma State Health Department.
- 4. Grave spaces and lots are transferable deeds.
- 5. A full lot consists of eight spaces; four on the east half and four on the west half. Lots and spaces will be sold from the cemetery map maintained by the Superintendent.
- 6. Burial spaces will be paid for at the time of selection. Exceptions may be granted by the City Clerk but must be paid out in payments not to exceed six (6) months. In the event spaces are not paid for in six months, the grave spaces not used for burial will revert back to the cemetery for resale.
- 7. Grave opening and closing charges will be paid in full at the time of completion.
- 8. No permanent flowerpots (e.g. concrete, plastic, etc.) will be allowed unless positioned on the monument or base of monument.
- 9. No curbs, fences or gravel will be permitted around, or on, any grave space or lot in the cemetery.
- 10. Planting of shrubs, bushes and flowers must be approved by the Superintendent.
- 11. Flowers, plants and sprays placed on graves will be removed when it is apparent or is felt by the Superintendent that they have served their purpose.
- 12. All monuments, markers, and memorials will have a concrete foundation large enough and deep enough in the opinion of the Superintendent so as to keep the monument, marker or memorial level and to ensure permanency. All monuments, markers and memorials must extend six (6) inches around all sides to permit proper maintenance operations.
- 13. Each grave space shall have only one marker, memorial, or monument. (For example, a monument may not be placed at both ends of an individual space.)
- 14. Road networks may be closed, altered, or changed by the Management.
- 15. These rules and regulations are effective as of August 1, 1976, and may be changed at any time by the City government to permit more efficient operation of Oaklawn Cemetery.
- 16. No pine boxes are to be used.
